Market research

You have the right to withdraw your consent to Us using your personal data at any time, and to request that We delete it.

We do not keep your personal data for any longer than is necessary in light of the reason or reasons for which it was first collected. Data will therefore be retained for no more than 12 months, unless you enter into a contract for the sale of goods and/or services with Us, where the data will be retained for 6 years following the completion of the contract. In the case where consent is given to use the data for marketing purposes, the data will be kept until you inform us that you no longer wish us to use the data.

How and Where is the data stored

The data is stored in the UK and suitable measures are taken to safeguard and secure the data collected.

Do We Share Your Data?

We will not share any of your data with any third parties for any purposes, however in certain circumstances We may be legally required to share certain data held by Us which may include your personal data. These circumstances could include complying with a court order/legal obligations or a governmental authority.

We may sometimes contract with third parties to supply services to you on Our behalf. These may include payment processing, delivery of goods, advertising, and marketing. In some cases, the third parties may require access to some or all of your data. Where any of your data is required for such a purpose, We will take all reasonable steps to ensure that your data will be handled safely, securely, and in accordance with your rights, Our obligations, and the obligations of the third party under the law.
